SHARED SERVICES AGREEMENT BY AND BETWEEN NORTHWEST BERGEN COUNTY UTILITIES AUTHORITY AND BERGEN COUNTY UTILITIES AUTHORITY FOR QUALIFIED PURCHASING AGENT SERVICES

This Shared Services Agreement (the "Agreement") is made and entered into this day of July 2022, by and between the Bergen County Utilities Authority, a duly formed county utilities authority organized and existing under the laws of the State of New Jersey pursuant to the Municipal and County Utilities Authority Law, <u>N.J.S.A.</u> 40:14B-1 <u>et seq</u>. (the "MCUA Law"), with its principal offices located at Foot of Mehrhof Road, Little Ferry, New Jersey 07643 (hereinafter referred to as the "BCUA") and the Northwest Bergen County Utilities Authority, a duly formed county utilities authority organized and existing under the MCUA Law, with its principal offices located at 30 Wyckoff Avenue, Waldwick, New Jersey 07463 (hereinafter referred to as the "NBCUA"; collectively with BCUA, the "Parties", or individually a "Party").

RECITALS

WHEREAS, the BCUA and the NBCUA are each a county utilities authority organized and existing pursuant to the MCUA Law to provide the services enumerated in <u>N.J.S.A.</u> 40:14B-2 of the MCUA Law, which services include but are not limited to the collection, treatment and disposal of storm water and wastewater; and

WHEREAS, the Uniform Shared Services and Consolidation Act, <u>N.J.S.A.</u> 40A:65-1 <u>et seq</u>. (the "USS Act"), authorizes any local unit of the State to enter into a shared services agreement with any other local unit(s) for the joint provision within the several jurisdictions of any service which any party to the agreement is empowered to undertake within its own jurisdiction; and

WHEREAS, the State of New Jersey, consistent with the USS Act, encourages local units, such as the BCUA and the NBCUA, to enter into agreements for the joint provision of governmental services as is authorized by the USS Act; and

WHEREAS, <u>N.J.S.A.</u> 40:14B-20 of the MCUA Law authorizes and permits the BCUA and the NBCUA to enter into any and all contracts, execute any and all instruments and do and perform any and all acts or things necessary, convenient or desirable for the purposes of either of the Parties or to carry out any power expressly given to either of the Parties pursuant to <u>N.J.S.A.</u> 40:14B-1 <u>et seq.</u>, expressly subject to <u>N.J.S.A.</u> 40A:11-1 <u>et seq.</u> (the "Local Public Contracts Law"); and

WHEREAS, <u>N.J.S.A.</u> 40:14B-20 authorizes and permits each of the Parties to enter into any and all contracts, execute any and all instruments and do and perform any and all acts or things necessary, convenient or desirable for the purposes of that Party or to carry out any power expressly given to it pursuant to <u>N.J.S.A.</u> 40:14B-1 <u>et seq.</u>, expressly subject to the Local Public Contracts Law; and

WHEREAS, the NBCUA, like the BCUA, requires the services of a Qualified Purchasing Agent to perform the requisite duties associated with such title as set forth in <u>N.J.A.C.</u> 5:32-4, to administer and/or implement the rules and regulations promulgated thereunder, as amended, ("Qualified Purchasing Agent Services") for the NBCUA on an as needed basis; and

WHEREAS, the BCUA and the NBCUA further discussed the benefits to the Parties entering into this Agreement, pursuant to which the BCUA will allow the NBCUA to utilize Gerald Reiner, a certified Qualified Purchasing Agent, Certification No. Q-1632, who serves as the BCUA's Qualified Purchasing Agent, to serve as the NBCUA's Qualified Purchasing Agent and to provide Qualified Purchasing Agent Services to NBCUA on an as needed basis during the time period of August 1, 2022 through and including December 31, 2022, as is authorized by N.J.S.A. 40A:11-9(a); and

WHEREAS, the Parties, having each determined it is in their respective best interests and the best interests of their ratepayers to enter into this Agreement, are desirous of entering into this Agreement subject to the terms and conditions as are set forth in this Agreement pursuant to which the BCUA will allow the NBCUA to utilize Gerald Reiner, a certified Qualified Purchasing Agent, Certification No. Q-1632, who serves as the BCUA's Qualified Purchasing Agent, to serve as the NBCUA's Qualified Purchasing Agent and to provide Qualified Purchasing Agent Services to NBCUA on an as needed basis during the time period of August 1, 2022 through and including December 31, 2022; and

WHEREAS, this Agreement will be for the period commencing August 1, 2022 and shall continue and renew, unless terminated by either Party as herein provided, and shall remain in full force and effect beyond the initial term until said Agreement is terminated by either Party or until all services to be provided by the BCUA to the NBCUA pursuant hereto are completed.

NOW, THEREFORE, in consideration of the mutual promises and covenants contained herein, the receipt of valuable consideration, the adequacy of which is hereby acknowledged, the Parties hereto do hereby agree as follows:

1. <u>Recitals</u>. The Recitals set forth above shall be and are hereby incorporated into and form a part of this Agreement.

2. <u>Effective Date</u>. This Agreement shall become effective following being legally approved by the BCUA and the NBCUA in accordance with applicable law. The effective date of this Agreement shall be August 1, 2022.

3. <u>Qualified Purchasing Agent Services and Agreement Term</u>. The BCUA shall allow the NBCUA to utilize Gerald Reiner, a certified Qualified Purchasing Agent, Certification No. Q-1632, who serves as the BCUA's Qualified Purchasing Agent, to serve as the NBCUA's Qualified Purchasing Agent and to provide Qualified Purchasing Agent Services to NBCUA on an as needed basis during the time period of August 1, 2022, through and including December 31, 2022 (the "Qualified Purchasing Agent Services Term"). 4. <u>Financial Terms</u>. For the provision of the Qualified Purchasing Agent Services during the Qualified Purchasing Agent Services Term pursuant to this Agreement, the NBCUA shall make payment to the BCUA, and the BCUA shall accept payment from the NBCUA, in the amount of Four Thousand One Hundred Sixty-Six and 67/100THS (\$4,166.67) Dollars, calculated based upon the rate of Ten Thousand and 00/100THS (\$10,000.00) Dollars per annum (the "Qualified Purchasing Agent Services Fee"), payable in a single lump sum payment to be delivered by the NBCUA to the BCUA.

5. <u>Premises</u>. This Agreement is contemplated by the Parties with the understanding and commitment by each that BCUA shall allow the NBCUA to utilize Gerald Reiner, a certified Qualified Purchasing Agent, Certification No. Q-1632, who serves as the BCUA's Qualified Purchasing Agent, to serve as the NBCUA's Qualified Purchasing Agent and to provide Qualified Purchasing Agent Services to NBCUA on an as needed basis during the Qualified Purchasing Agent Services Term.

6. <u>Successors and Assigns</u>. The terms of this Agreement shall be binding upon all transferees, successors, grantors and/or assigns of the Parties as though named in this Agreement.

7. <u>Notice</u>.

A. All notices, request, or approvals required or permitted under this Agreement shall be in writing and shall be deposited in the United States mail, postage prepaid, and shall be registered or certified or may be provided via personal service or via Federal Express or other recognized national overnight mail carrier.

B. If intended for the NBCUA, such notice(s) shall be sent to:

C. If intended for the BCUA, such notice(s) shall be sent to:

D. Either Party may, by like notice, designate any further or different address to which subsequent notice(s) shall be sent. Any notice(s) sent hereunder signed on behalf of the notifying Party by a duly authorized attorney-at-law shall be valid and

effective to the same extent as if signed on behalf of such Party by a duly authorized officer or employee.

8. <u>Miscellaneous</u>.

A. <u>Cooperation</u>. The Parties agree to attend meetings as may be needed to evaluate and modify the Qualified Purchasing Agent Services to be provided by the BCUA to NBCUA pursuant to this Agreement.

B. <u>Termination</u>. Notwithstanding any provision in this Agreement to the contrary, either Party may terminate this Agreement upon thirty (30) days' written notice to the other, without further liability to the other.

C. <u>Invalidity</u>. If any provision of this Agreement shall to any extent be held unenforceable or invalid by a court of competent jurisdiction, the remaining provisions of this Agreement shall not be affected thereby.

D. <u>Agreement/Modifications</u>. This Agreement contains the entirety of the agreement between the Parties and supersedes any and all prior or other oral Agreements between the Parties with respect to the provision of Qualified Purchasing Agent Services by the BCUA to and on behalf of the NBCUA. There are no other oral Agreements or presentations binding the Parties hereto and this Agreement may only be altered, modified or amended only in writing executed by each of the Parties hereto.

E. <u>Governing Law</u>. This Agreement shall be governed by the laws of the State of New Jersey without giving effect to the principles of conflict of laws.

F. <u>Counterparts</u>. This Agreement may be signed and executed in one or more counterparts and all such counterparts shall constitute one and the same document binding on the Parties hereto and the failure of the Parties to be mutually present during such signing or execution and/or the failure of all Parties' signatures to appear on the same original of this Agreement shall not be construed as taking from the validity and effect of same.

G. <u>Independent Parties</u>. The relationship of the Parties hereto is that of independent contractors and this Agreement does not create a joint venture, partnership or agency between these Parties. Each Party shall remain solely responsible for payment, benefits, adequate insurance coverage, and workers' compensation programs covering the own respective employees.
