



AUTHORIZATION TO ADJUST CONNECTION FEE

WHEREAS, after a public hearing on December 6, 2006, as set forth in the Resolution adopted on said date, the Northwest Bergen County Utilities Authority (the "Authority") determined that it would be in the best interest of the public and the local government units it serves to institute a connection fee program in the manner prescribed by N.J.S.A. 40:14B-23, and to adopt the necessary amendments to the Authority's Rules, Regulations and Standards required to implement the connection fee program; and

WHEREAS, at the hearing on December 12, 2024, the Authority determined that the cost of the connection fee for the year 2025 would be \$5,757.00 per service unit as calculated in the 2025 Sewer Connection Fee Rate Study prepared by Wielkotz & Company, LLC; and

WHEREAS, the firm of Wielkotz & Company, LLC, the auditor for the Authority, has prepared a report entitled "2026 Sewer Connection Fee Rate Study Update" (hereinafter sometimes referred to as the "Report") for the Authority, with the assistance of the Authority staff, on the proper amount for a connection fee payable by an individual or party making a new connection to the System for the year 2026, in accordance with the formula set forth in N.J.S.A. 40:14B-22, for the privilege of making the connection ("2026 Sewer Connection Fee Rate Study Update"); and

WHEREAS, the connection fee per service unit as calculated in the Report is \$5,939.00; and

WHEREAS, on December 17, 2025, in accordance with the requirements of N.J.S.A. 40:14B-22, the Authority conducted a public hearing on the proposed adjustment of the connection fee prescribed by N.J.S.A. 40:14B-23; and

WHEREAS, the Authority, having considered, at the public hearing held on December 17, 2025: (i) 2026 Sewer Connection Fee Rate Study Update; and (ii) the statements of those attending the public hearing; and has determined that it would be in the best interest of the Authority to adopt an adjustment to the connection fee charge implemented for the year 2026; and

WHEREAS, the Authority has determined that the cost of the connection fee will be \$5,939.00 per service unit for 2026.

NOW, THEREFORE, BE IT RESOLVED by the Commissioners of the Northwest Bergen County Utilities Authority, as follows:

1. The Authority hereby establishes an adjustment to the connection fee of \$5,939.00 per service unit for 2026, effective as of January 1, 2026, until amended.
2. The Executive Director is hereby authorized to take any and all steps necessary for the implementation of the adjustment of the connection fee.





RESOLUTION AUTHORIZING THE NORTHWEST BERGEN COUNTY UTILITIES AUTHORITY TO APPROVE A SEWER CONNECTION APPLICATION WITH CLAREMONT PROPERTIES ACQUISITIONS, LLC FOR THE 425 ISLAND ROAD, RAMSEY, NEW JERSEY SEWER CONNECTION

WHEREAS, the Northwest Bergen County Utilities Authority (the “NBCUA”) has previously determined the need for and facilitated the construction of sanitary sewer lines within the Borough of Ramsey (the “Borough”); and

WHEREAS, the NBCUA has previously resolved to construct sanitary sewer lines to assist in the collection and disposal of sanitary and other waste waters arising within the boundaries of the Borough of Ramsey; and

WHEREAS, the NBCUA has received a Sewer Connection Application from Claremont Properties Acquisitions LLC regarding 425 Island Road, Ramsey, New Jersey (proposed multi-family residential development consisting of 70 townhomes) who is desirous of collaborating with the Borough of Ramsey for the connection to an existing Borough of Ramsey sanitary sewer located on Island Road. The proposed connection/extension is designed to provide sanitary sewer service to a proposed multi-family residential development consisting of seventy (70) townhomes. The proposed connection will involve constructing approximately 1,647 linear feet of 8-inch PVC sewer main, twelve (12) manholes, and appurtenances to collect and dispose of sanitary and other wastewater arising within the boundaries of 425 Island Road of the Borough of Ramsey and to be received and serviced by the NBCUA. The application for this connection/extension projects an average daily flow of 14,485 gallons per day (GPD). The existing home to be demolished had an estimated flow of 150 GPD. Based on these projections, the additional estimated flow is 14,335 GPD and sixty-nine (69) additional residential equivalent dwelling unit (“EDU”) will become tributary to the Authority from the Borough of Ramsey, (“Project”); and

WHEREAS, the NBCUA Technical Advisor, Samuel N. Brewer submitted a memorandum November 25, 2025, to the Executive Director and NBCUA’s General Counsel indicating that the Authority currently has sufficient capacity to accept the additional flow from this Project and recommended the approval of the Sewer Connection Application by the Authority;

NOW, THEREFORE, BE IT FURTHER RESOLVED, by the Commissioners of the Northwest Bergen County Utilities Authority as follows:

1. The Authority hereby authorizes the approval of the Sewer Connection Application submitted by Claremont Properties Acquisitions LLC, subject to the following Authority requirements;
2. Construction in conformance with all applicable requirements of the Borough of Ramsey, where applicable.
3. Inspection and approval of the installation of sewers, appurtenances by the Borough of Ramsey, where applicable.
4. Observation and approval by the Authority of infiltration/exfiltration testing, with the Authority to receive two (2) days advanced notice prior to the testing of all newly constructed sewers.
5. Reimbursement to the Authority by the applicant for all engineering expenses incurred by the Authority for inspection and final testing of the sewers and appurtenances.

The Northwest Bergen County Utilities Authority shall be responsible for ensuring that all the construction of sanitary sewer lines comply with all laws of the State of New Jersey Local Public Contracts Law, N.J.S.A. 40A:11-1 et. seq., and all other provisions of the revised statutes of the State of New Jersey.
