WHEREAS, the recent changes to the Local Public Contracts Law gave local contracting units the ability to increase their bid threshold from \$36,000 to \$40,000; and

WHEREAS, the quotation threshold for local units with Qualified Purchasing Agents, is tifteen percent (15%) of the bid threshold, which increases the new quotation threshold from \$5,400 to \$6,000; and

WHEREAS, N.J.S.A. 40A:11-3 permits an increase in the bid threshold if a qualified Purchasing Agent is appointed as well as granted the authorization to negotiate and award such contracts below the bid threshold; and

WHEREAS, Robert Genetelli was appointed on March 2, 2010 by Resolution No. 22-2010 as the Qualified Purchasing Agent for the Authority; and

WHEREAS, the Northwest Bergen County Utilities Authority desires to take advantage of the increased bid threshold.
